Donor Advised Fund Spotlight: The Wallace Family

Bob and Diane Wallace have always viewed volunteering as a way to give back. In recent years, their views on giving back have expanded to now include philanthropy. When their children, Ryan and Lauren, were young, the Wallace family actively engaged in numerous service-oriented projects, embedding their commitment to community as a fundamental family value. As their children grew older and started families of their own, the Wallaces felt a desire to impart philanthropic values on their growing family, now involving all generations in a meaningful journey to give where they live here in Lake County.

When exploring how to accomplish their family's philanthropic vision, the Wallaces initially considered creating their own family foundation.

"After researching this option, it seemed to us that too much energy and too many resources would need to be spent on administrative items - tax filings, obligatory board meetings and annual required distributions," Diane and Bob shared. The administrative downside of creating their own foundation took away from spending time and energy where it mattered most to Diane and Bob - creating positive impact in their community.

After meeting with LCCF, the Wallaces learned that a donor advised fund (DAF) could provide them with the administrative infrastructure to achieve their philanthropic vision. This would allow their family to focus more on identifying impactful organizations to fund rather than being concerned about administrative duties.

"What really sealed the DAF decision for us was that we got to know LCCF personally. LCCF focuses on Lake County and intimately knows about the many philanthropic opportunities

available," Diane and Bob shared. With LCCF as a partner, the Wallaces' main focus will be promoting equitable access to education and work opportunities, recognizing that these avenues are not always accessible on an equal footing for everyone.

Diane and Bob established the Lawrence Wallace Charitable Fund by donating an investment property. LCCF worked with a partner to liquidate the property and transfer the proceeds to the DAF. This allowed the family time to concentrate collectively on how they might begin addressing some of the social justice issues that they care about most.

Bob and Diane's decision to transform a passive investment property into an active vehicle for charitable giving has provided a family platform for lasting impact. As the Wallace family embarks on their philanthropic journey, they are excited to create an enduring family legacy within Lake County. In Bob and Diane's words, "We would like our family's future generations to push for an overused but very definable goal – leave the world a better place than you found it."

More on DAFs

Interested in starting your family's charitable legacy with a donor advised fund? Here are three quick and easy steps:

1 Assess your assets

Appreciated stock, real estate and artwork are all great and acceptable ways to start a DAF. You may also write a check. The minimum to start a fund is \$10,000.

2 Identify your passions

What are you passionate about in Lake County? Your fund may have a general or specific charitable purpose. For example, if you are passionate about education, you can specify that the DAF only grants to organizations that relate to education. 3 Name your fund

The fund can be named after your family or a loved one. For example, the "Jones Family Fund" or the "James Miller Memorial Fund." Or you can name the fund for the specific funding area as in the "Jones Family Education Fund."

Your Legacy As Part Of A **Thriving Lake** County

How do you envision being remembered in your community?

You may want to preserve your family name, honor loved ones or minimize tax burdens. Charitable gift planning with LCCF allows you to accomplish all of the above while ensuring your family's name and influence remain intertwined with the community for generations to come.

Making a legacy gift doesn't have to be complex, cost-prohibitive or time consuming. In fact, there are four ways to leave a legacy gift without changing your will:

- Name LCCF a beneficiary of any percentage of remaining funds in your IRA, 401(k), 403(b) or other defined contribution retirement plan.
- Name LCCF a beneficiary of any portion of the death proceeds from a life insurance policy.
- Instruct your bank to transfer any portion of what remains in your account at the end of your life to LCCF.
- - Instruct your brokerage firm to transfer any portion of investments held at the end of your life to LCCF.

Each method requires a simple change of beneficiary form provided by your financial institution. When LCCF is named as beneficiary through one of these arrangements, the proceeds are not governed by your will and are not subject to probate.

- Community Ownership
- Rapid Community Response

Our Program & Community Investment Strategy drives our work and priorities. The strategy is guided by the principles of trustbased philanthropy, equity and addressing root causes. We are committed to ensuring that we are using these lenses in our programs, grantmaking, our organizational culture and in all that we do.

Trust-Based Philanthropy

Trust-based philanthropy is envisioning a world where relationships are built on vulnerability, transparency and humility; where community and nonprofit leaders are valued, supported and trusted; and where funders bring an awareness of power and equity to their grantmaking.

Equity

Equity is an approach that assesses resource, opportunity and access. It is a lens that considers historical and systemic factors that have disproportionately affected communities of color and acknowledges the need for tailored, multi-faceted approaches to ensure all individuals can thrive.

Addressing Root Causes and Systemic Change

This entails policies, practices and power structures to remedy complex issues. We must address the root causes of complex problems with a holistic approach to catalyze sustainable, transformational change.

We envision a Lake County where neighbors have the resources and power to heal and generate pride within their neighborhoods; all individuals deserve equitable access to building generational wealth and opportunities to reimagine and create sustainable communities. We are intentionally shifting our philanthropic power, resources and focus to historically disinvested communities so that everyone has access, resources and opportunity.

The Vision In Action

Through strategic use of our unique position, combined with our passion, knowledge of Lake County and utilization of our extensive network, we actively bridge gaps within our community. Equipped with expertise, valuable connections and a profound commitment to sustainable change, we intend to create enduring, multigenerational impact.

Our programs thrive due to our holistic approach, addressing root causes of various issues with a comprehensive understanding of Lake County's complex challenges. As an example, our **Small Business Growth Initiative (SBGI)**, initiated by the community, has experienced exponential growth, bolstered by collaborative support from our partners. This year, in partnership with Allies for Community Business, we provided funding, coaching and connections to help five small business owners grow their businesses, create jobs and build wealth in Waukegan. Justin Coyoc, 2207 Grand Ave. The Lake County Community Foundation's **Community Ownership Pillar** supports community-centric initiatives by shifting decision-making power to the community. We believe that vibrant, diverse and equitable communities can only be achieved through active participation, especially by communities often excluded from philanthropic efforts, ensuring everyone has power and resources for change. In 2023, we funded six community leaders from North Chicago, Waukegan and Zion, and their projects, each dedicated to reimagining their respective communities and initiating intergenerational change.

The Mirror Image Project

Jonathan Stephens, a local photographer and owner of Just Shoot Me Photography, is dedicated to spotlighting the significance of Black father-son relationships and fostering positive self-images among Black men. He utilizes photography as a means to reshape the negative narratives that impact his community and others facing similar challenges. With support from LCCF, Jonathan organized an event offering complimentary photo sessions to Black men and their children.



Being a single father with a 12-year-old son and a professional photographer for 13 years, I noticed my client base was predominantly women with kids. The beautiful images I would publish were always absent of the father. I then did an online search and noticed the images that represented me, a Black man, as a father with a son, were not the most flattering, positive images. I want to change the narrative of Black fathers. I took the two things most dear to me (being a father and a photographer) and created The Mirror Image Project to display positive images of fathers and sons. Positive images are so vital to our young boys and adult men. When you look nice and well-groomed, you feel nice and carry that feeling into your community and inspire others.


